**BOND REDEMPTION PROCEDURE**  
**for 2018 & prior year BOND HOLDERS**

Your Bond is valued at **\$375.00 (2018 & prior) & (2019 to present \$200.00 less tax.)**

If you wish to redeem your bond, you must send a written request to Westwood. If there is no one available to purchase your bond, you remain obligated to pay your dues for **2021**. The dues must be paid by **May 15<sup>th</sup>, 2021**, or you will forfeit your bond value and membership privileges.

If you pay your dues and your bond is purchased by **May 15<sup>th</sup>, 2021**, then you are eligible for a full refund of your dues and your bond.

If you pay your dues and your bond is purchased after **May 15<sup>th</sup>, 2021** then you will receive your bond redemption in the fall. Dues are not refundable after **May 15<sup>th</sup>, 2021**, but you will of course enjoy full membership during the **2021** season.

## WESTWOOD SWIMMING & TENNIS ASSOCIATION 'Senior Citizen' BY-LAWS REVISION – Approved 2015

Section 5. (a) A “**Senior Citizen Membership Conversion**” is defined as an existing and current bond holder in good standing who have been bond holding member(s) for a minimum of ‘5’ consecutive years and who are at least ‘62’ years of age.

Such persons are eligible for this class of membership at the current Special Membership cost, which is stated every year when the dues notices are mailed and posted on our website.

Senior Citizen Membership **does not** include Association **VOTING** privileges and limits **10 GUESTS** per season at the seasonal rate.

*For the 2021 season the rate will be **\$199.00 each** including tax*

Section 5. (b) A “**Senior Citizen Membership Non-Conversion**) is defined as a senior who is at least ‘62’ years of age and who **has not** been a current bond holding member in good standing for a minimum 5 consecutive years.

Such persons are eligible for this class of membership at the current Special Membership cost, which is stated every year when the dues notices are mailed and posted on our website.
